FAMILIES RECEIVED CRITICAL SUPPLIES SUCH AS DIAPERS, WIPES, AND HYGIENE ITEMS, ALONG WITH EDUCATIONAL MATERIALS AND COMMUNITY RESOURCE REFERRALS TO SUPPORT LONG-TERM FAMILY STABILITY. OUR SERVICES HELP PREVENT FAMILIES FROM FACING IMPOSSIBLE CHOICES BETWEEN BASIC NEEDS LIKE FOOD, UTILITIES, AND CHILDCARE.
